Shamsul Alam, Dept. of Islamic Studies, DU (Subject Expert); Prof. Dr. Mushtaq Ahmed, Head, Dept. of Civil Engineering, LU; Prof. Md. Abul Kalam Chowdhury, Dept. of BuA, LU; Mr. Md. Rashedul Islam, Asst. Prof. & Head (Acting), Dept. of Law, LU and Colonel (Retd) Md. Mosharrof Hossain, Registrar, LU as the new members of the Academic Council. He then requested the Member Secretary to proceed with the Agenda of the meeting. Agenda 10 (1): Confirmation of the Minutes of 9th Academic Council meeting.

Decision:

The minutes of the 9th Academic Council meeting was read in the meeting and was confirmed without any change.

Agenda 10 (2): Approval of the Reviewed Syllabi of different Programs of all Depts of LU;

Decision:

The Agenda was withdrawn from the meeting as the Syllabi of different Programs of all Department those were approved in the last (9th) Academic Council are yet to be implemented. It was decided that after thorough study, if it is necessary to amend any syllabus that can Be placed in the next Academic Council meeting.

Agenda 10 (3): Approval of the Results of the Graduating Students of Leading University from Fall 2012 to Fall 2013;

Decision:

The result of 858 (both Sylhet and Dhaka Campus) students was placed and presented in the meeting. The members of the Academic Council opined to be concerned about the evaluation of students' performance and assigning grade rationally. After a threadbare discussion on the results and evaluation process the result of 762 graduating students of Sylhet Campus and 96 graduating students of Dhaka Campus from Fall 2012 to Fall 2013 has been approved by the Academic Council. It was further decided that a 3 (three) member Internal Audit/ Scrutiny Committee shall be formed by the Vice Chancellor to verify the authenticity of the result that was placed by the Controller of Exams in the 10th Academic Council meeting and a certificate/ report in this respect from the Internal Audit/Scrutiny Committee has to be placed in the next Academic Council meeting. The Academic Council also opined that the Academic Council meeting should be held thrice in a year and the result of the previous semester has to be placed in the Academic Council meeting along with the certificate/ report of the Internal Audit/ Scrutiny Committee. Agenda 10 (6): Opening of BA (Hons) and MA in Islamic Studies Programs and Approval of Syllabi of those Programs;

Discussion:

The objective of introducing BA (Hons) and MA in Islamic Studies Programs in LU is to produce new graduates in the era of Islamic Studies and religion through learning, discovery, and communication and to provide a comprehensive grounding in a major step towards helping the Muslim students of the country to fulfill the Prophet's command to seek knowledge of the religion and to correct and enhance their understanding of its tenets. The syllabus of this program has been prepared in light of that objective. The syllabus was sent to the Chairman, Department of Islamic Studies, DU for study and suggesting necessary change (s), if any. Prof. Dr. Shamsul Alam, a senior Professor of Dept.of Islamic Studies, DU attended the 10th Academic Council meeting as Invitee and extended his valuable suggestions regarding the syllabi of both the programs.
