### <u>Agenda 17 (3)</u>: Placement of the proposal for assigning supervisor for the students of LL.M Program having the course namely Research Monograph to maintain the general practice of Viva-Voce

#### **Discussion:**

Mr. Md. Abdul Musabbir Chowdhury, Assistant Professor & Head (Acting), Department of Law, Leading University applied on 14 September 2017 mentioning that the students of LL.M Program have a course namely Research Monograph and at the end of the said course there is Viva-Voce which generally consists of only 03 (three) members for all of the students and only the course teacher is assigned as the supervisor for all of the said students. He has also mentioned that the practice of other Private Universities including Leading University is the different department follows the rule of forming different Viva Board for such kind of course when there are more than five to ten students in that particular course regarding assigning of supervisor for the to maintain the general practice of Viva-Voce. Mr. Chowdhury recommended that a general practice regarding Viva-Voce and assigning Supervisor is needed for consistency and betterment of the student having the above mentioned course.

#### **Decisions:**

The Academic council suggested the Department of Law to collect and study the curriculum of the different universities and discuss in the Departmental Curriculum Committee and submit its report to the next Academic Council.

# Agenda 17 (4): Placement of Reports of the Committees formed to analyze and find out the facts behind constant dropping out of students of the different departments of LU

#### **Decision:**

The Reports of the Committees formed to analyze and find out the facts behind constant dropping out of students of the different departments of LU were presented by the concerned Head of the Departments. After a threadbare discussion the Academic Council recommended the following observations and suggestions and instructed the committees to submit their modified reports to the next Academic Council meeting.



- i) The concerned department has to communicate with the different groups of students, their parents or guardians and find out the real facts behind constant dropping out of students of their department.
- ii) The concerned committees have to change the methodology of their research to capture the real causes of dropouts.
- iii) The authority has to take initiative for conducting internal quality assessment at department level in line with the IQAC guidelines.
- iv) The Committees have to submit their reports in the next AC meeting based on real ground level data collection and analysis of the dropout students with appropriate sample size and stakeholders mentioning the exact number, percentage and reason.
- v) The faculty members must have to work both inside and outside of class rooms for development of weak students and make them able to understand class lectures as well as capable to obtain the degree with a standard CGPA that makes them competitive for job markets, nationally and globally.

### <u>Agenda 17 (5)</u>: Placement of revised Draft Proposal and Ordinance of Centre for Modern and Indigenous Languages at LU

#### Decision:

The Academic Council approved the revised Draft Proposal and Rules & Regulations of the Centre for Modern and Indigenous Languages at LU with some observations and suggestions and instructed the concerned committee to submit the same to the next Academic Council meeting with the following modifications:

- a. Clause-1: The text "The Centre shall act as an Institution" will be replaced by "The Centre shall act like an Institute".
- b. Clause 2 b: The text "Short term" and "Long term" will be deleted.
- c. Clause 6: The text "No candidate shall be allowed to appear at the final examination unless he/she has attended 60% (sixty) percent of the lectures delivered" will be replaced by "No candidate shall be allowed to appear at the final examination unless he/she has attended at least 60% (sixty) percent of the classes".
- d. Clause 7. a) (iv): The text "test" will be deleted.
- e. Clause 7. a) (v): The text "a passage" will be deleted.
- f. Clause 7. b) (i): The text "200 (two hundred)" will be replaced by "150 (one hundred fifty)".
- g. Clause 7. b) (ii): The text "40 (forty)" will be replaced by "50 (fifty)".
- h. Clause 7. b) (iii): The text "20 (twenty)" will be replaced by "50 (fifty)".
- i. Clause 7. b) (iv): The text "10 (ten)" will be replaced by "20 (twenty)".
- j. Clause 7. b) (vi): The text "a passage" will be deleted.
- k. Clause 7. d): The text "paper" will be replaced by "course".
- 1. Clause 9. : The text "If any examinee adopts unfair means in the Examination hall, he/she shall be declared unsuccessful for that paper only" will be replaced by "Examinations to be conducted as per LU rules and regulations".
- m. Clause 7. d) : The text "paper" will be replaced by "course".
- n. Clause 8. The text "B- (b minus)" will be replaced by "B- (B minus)".
- o. Clause 10 (f). : The text "After publishing the results, the Director shall issue the Certificates and marks certificates/transcripts to the passed-out candidates" will be replaced by "Certificates and marks certificates/transcripts to the passed-out candidates will be issued as per university rules".
- p. The text "Center" will be replaced by "Centre" throughout the text of the Rules and Regulations.
- q. The assessment of each course will be made on 04 (four) modules i.e. i) Reading, ii) Writing, iii) Speaking and iv) Listening with the equal distribution of marks.
